Dear Head of Council:

We are writing to announce the release of the 2019 Ontario Municipal Partnership Fund (OMPF) allocations.

As communicated in February, the government is maintaining the current structure of the OMPF for 2019. This means the program is the same as it was in 2018, while allowing for annual data updates and related adjustments.

Consistent with prior years, Transitional Assistance will ensure that the 2019 funding guarantee for municipalities in northern Ontario will be at least 90 per cent of their 2018 OMPF allocation and for municipalities in southern Ontario will be at least 85 per cent of their 2018 OMPF allocation.

Northern and rural municipalities with the most challenging fiscal circumstances will continue to have their guarantee enhanced up to 100 per cent of the prior year's allocation.

As in prior years, Transitional Assistance continues to adjust in 2019 as fewer municipalities require this funding. As a result, the 2019 OMPF will provide a total of \$505 million to 389 municipalities across the province.

The Ministry of Finance's Provincial-Local Finance Division will be providing your municipal Treasurers and Clerk-Treasurers with further details on the 2019 OMPF. This information and other supporting materials will be posted online at http://www.fin.gov.on.ca/en/budget/ompf/2019.

We look forward to consulting with municipalities to ensure the OMPF program is sustainable and focused on the Northern and rural municipalities that need this funding the most. We are committed to announcing the 2020 allocations well in advance of the municipal budget year so you have appropriate time to plan.

We are writing to provide you with an update on the Ontario Community Infrastructure Fund (OCIF). and new opportunities to access federal and provincial infrastructure funding under the Investing in Canada Infrastructure Program.

Firstly, we are pleased to confirm your municipality's eligibility for the OCIF 2019 Formula-Based Component and provide you with the enclosed Revised Allocation Notice. The notice confirms the previously-proposed 2019 allocation for your community.

We would also like to take this opportunity to remind you of the steps required to close-out your 2018 Formula Funding. A 2018 Annual Financial Overview will be provided to you shortly, along with an Annual Financial Report (AFR) template for you to complete. In the AFR you will be required to confirm details of projects in progress or recently completed, report on any transfers (in or out) for joint projects with other eligible OCIF recipients, indicate the amount of interest earned on formula funds, and confirm any amounts that will be carried forward to 2019. Detailed instructions will be provided when the forms are sent to you.

As your Revised Allocation Notice is being sent out later than normal, the timing of reports as noted in the Contribution Agreement (CA) under Section I2.1 will be revised for this year. The 2018 AFR should be provided by May 31, 2019 and the Project Information Reports required to substantiate the 2019 allocation should be provided by June 30, 2019. Any questions regarding this timing should be sent to <u>OCIF@ontario.ca.</u>

Failure to complete these reporting requirements and any other requirements included in your CA by the noted deadlines could impact your ability to receive formula payments in 2019 and beyond.

As you know, the government is making every effort to restore fiscal balance to the Province. We are using the Province's recent line-by-line review to make all government spending more effective and reduce Ontario's fiscal burden.

Based on this review, the province will be updating the design of OCIF, including the formula and application streams, to make sure funding is targeted to where it is needed most.

In the meantime, proposed formula-based allocations for 2020 and 2021 cannot be confirmed. This means that the previously-proposed allocations for 2020 are subject to change pending the outcome of

the program update. In addition, we are cancelling the top-up application intake that closed in August of 2018 as well as the 2019 top-up application intake.

We will work with our municipal partners to ensure that the refined OCIF program supports efficiency and value-for-money while helping to address municipal critical infrastructure needs.

Although the government will not be proceeding with the 2018 Top-Up Application Component, road and bridge projects were still reviewed and evaluated based on the criteria outlined in the OCIF program guidelines. Our multi-ministry assessment team identified that your project would not have been successful under the program.

As you may know, the Province is launching the Investing in Canada Infrastructure Program (ICIP) in Ontario. ICIP is a ten-year program, which will commit up to \$30 billion in combined federal and provincial funding to support public transit, green infrastructure, community, culture and recreation, and rural and northern infrastructure investments. Details on ICIP will be available starting on March 18, 2019 including details on the launch of the first intake of ICIP, the Rural and Northern stream.

We are pleased to submit the 2018 report in compliance with the reporting requirements for the McMillan Gravel Pit. The "Monitoring Program –McMillan Property" follows the original protocol (Limnoterra Ltd. January 15, 1998) and modified with agreement from James Williams of your office on January 27, 2010.

Extraction ceased on the site in 2004 and in 2010 CBM requested and obtained a reduction of monitoring requirements from your office. Monitoring now conducted at this site is benthic macroinvertebrate sampling in tributary T3 and calculation of the water quality index based on BioMAP methods.

The analysis for 2018 includes data for the site from 1997 to 2018. Extraction activities ceased on the site in 2004, thus 2005 to 2018 monitoring data represents 14 years of post-extraction conditions.

Water Quality Rationale:

Tributary 3 of Mill Creek is the nearest discharge point of groundwater crossing the pit site and reflects the quality of groundwater discharging from the McMillan Pit (Figure 1). Water quality monitoring is based on an assessment of the benthic biota that Tributary 3 supports. The community of benthic biota is subject to the full rigor of the environment through the annual or biannual life cycles of the species. The community therefore represents the integrated temporal effects of all pollutants and environmental conditions through the year and not only those conditions at the time of sampling.

The composition of benthic macroinvertebrate communities reflects water and habitat quality in streams. BioMAP (Biological Monitoring and Assessment Program) is a water quality assessment tool designed for southern Ontario watercourses. It provides a quantitative measure of water quality that can be used to diagnose water quality at a site, monitor water quality over time, and evaluate the impact of point source and diffuse source pollution on water quality. The index calculated for a watercourse is based on sensitivity values assigned to each macroinvertebrate species. The sensitivity values are based on the species tolerance to factors of pollution. (organics, reduced dissolved oxygen, suspended solids, temperature, metals, acidity, nutrients etc).

Water Quality Methods:

Benthic macroinvertebrates were collected from Tributary T3 on October 22, 2018 (Figure 2). Two quantitative samples were collected from the site, downstream of Regional Side Road 20. A qualitative sample was taken from various types of habitat extending along the tributary length including the same general area as samples T1 and T2 and includes sampling from the small backwater area/wetland just upstream of Side Road 20. Sampling procedures followed the BioMAP protocols described in the BioMAP Report SWR-1¹ and have been outlined previously (refer to TCG McMillan Report 1996/1997). Aquatic Ecostudies Limited provided benthic identification services for the samples collected by 8Trees Inc.

Water Quality Analysis:

The BioMAP analysis methodology was used to analyze the results and obtain a Water Quality Index for the Tributary (WQI). Sensitivity values from *Version 110430 Sensitivity Values for Aquatic Macroinvertebrates* of Ontario were used for the 2018 analysis. Sensitivity Values can range from 4 to 0 which correspond to the longitudinal distribution of macroinvertebrates along the river continuum. A value of 4 designates species that typically inhabit small, groundwater fed, headwater creeks with a predominance of leaf and wood litter as the main energy source. A value of 3 corresponds to larger more open streams with solar radiation driving greater periphyton growth supporting species that feed on attached algae, and so on down to species ranked 0 that feed on fine particulate organic matter most abundant in turbid slow moving warm aquatic systems.

In the Mill Creek tributary T3 we expect to see a population dominated by species with ranks of 4 and 3 and a BioMAP analysis calculation of greater than 14 Water Quality Index (WQI).

Mean Sensitivity refers to the average sensitivity of the top 25% of the species collected. For Mill Creek we expect to see a Mean Sensitivity above 3.

Water Quality Proposed Trigger:

WQI > 14 (i.e. unimpaired condition). No negative impacts to water quality have occurred from extraction when WQI > 14 for Tributary T3.

Water Quality Results:

Results of the BioMAP analysis from 1997 – 2018 are shown graphically in Figure 3 and listed in Table 1. The WQI for 2018 is 19.2 (average of 22.6 at T1 and 15.9 at T2). Flow in the tributary at the time of sampling in October was adequate to take a full sample, similar to previous years.

The species composition collected in 2018 is similar to previous years and represents an unimpaired creek. The types of organisms found in 2018 are typical of a closed canopy, cool-to-cold water creek. The available habitat quality remains high as indicated by the presence of highly sensitive species.

Conclusion:

The water quality index remains above the trigger level of 14. The overall species composition continues to reflect the community collections of previous years and the benthic community in Tributary 3 remains representative of a southern Ontario unimpaired creek. No negative impacts to water quality due to extraction activities have been detected in the 2018 sampling.

As requested, I have reviewed the 2018 Water Monitoring Report for the McMillan Pit of CBM Aggregates which was prepared by 8 Trees Inc. Extraction activities ceased on this site in 2004 and hence the 2005 to 2018 monitoring data represents post extraction conditions. Over this period samples of benthic macroinvertebrates found in Tributary 3 were collected and analyzed. This Tributary of Mill Creek is fed by groundwater discharging from the McMillan Pit. The biological data continues to indicate an unimpaired creek with a similar species composition to that found in previous years. The types of organisms inhabiting this tributary are typical of a closed canopy, cool-to-cold water creek. The average Water Quality Index (WQI) for 2018 was 19.2 which is above the trigger level of 14 and the mean sensitivity value was above 3 which indicates high quality habitat conditions.

In conclusion, the monitoring data still indicates no negative impacts to water quality as a result of aggregate extraction. I have no concerns with the information presented in this report.

Dear Mayor/Chief:

As the Minister of Infrastructure, I would like to provide an update about some important actions our government is taking to ensure we provide predictable, secure infrastructure funding to address community needs, while reducing the administrative burden on local governments.

As part of this plan, I am pleased to announce the launch of the first stage of the Investing in Canada Infrastructure Program (ICIP) in Ontario. The ICIP is a 10-year federal-provincial infrastructure program that will invest up to \$30 billion in combined federal, provincial and other partner funding to critical local and regional infrastructure needs. The program will support public transit, green, community, culture and recreation, and rural and northern infrastructure investments. It will bring major infrastructure investments to communities across Ontario. It will grow our economy, ensuring Ontario is open for business and open for jobs. By leveraging funding from the federal government, the ICIP will help us deliver on our commitment to a balanced, fiscally-responsible plan that includes smart infrastructure investments and meets the needs of the people.

I am pleased to announce that the first intake for the ICIP, the Rural and Northern stream, will launch in days. An intake for the remaining Public Transit stream will open in the coming weeks, while intakes for the Community, Culture and Recreation stream and Green stream will launch later this year.

In cooperation with my colleague the Honourable Ernie Hardeman, Minister of Agriculture, Food and Rural Affairs, the initial intake of the Rural and Northern stream will open on March 18, 2019. Communities will have up to eight weeks to submit applications for provincial review and nomination to the federal government.

This intake will prioritize projects that improve transportation infrastructure through investments in road, bridge, air and/or marine infrastructure. Municipalities and First Nations with populations of 100,000 or less will be eligible to apply. Projects that will be considered must have a total cost of less than \$5 million, though municipalities and First Nations could submit joint applications for larger projects, such as shared county roads. Future intakes may prioritize other specific asset types eligible under ICIP, like broadband.

More information about the Rural and Northern stream can be found at: <u>www.grants.gov.on.ca/GrantsPortal/en</u>, by clicking on Grant Opportunities.

I would also like to provide an update on the Ontario Community Infrastructure Fund. As

you may be aware, the government committed, through a recent line-by-line review, to make all government spending more effective. As a first step, we will be confirming the 2019 OCIF formula allocations with eligible communities, with formula funding confirmed at \$200 million for 2019. Moving forward, the province will be undertaking a re-design of the Ontario Community Infrastructure Fund (OCIF) to ensure funding is targeted to where it is needed most. Our government will work with the Association of Municipalities of Ontario and municipalities to develop this re-focused OCIF.

Projects that were submitted to the 2018 top-up application intake were reviewed and evaluated based on the criteria outlined in the program guidelines. While no funding will be provided through the 2018 OCIF application intake, it is our intent to nominate a number of road and bridge projects – that would have been successful under the program – for federal funding under the Rural and Northern stream on an accelerated basis. Nomination is subject to municipal agreement and the submission of further information to ensure compliance with federal eligibility criteria. Ministry officials will be in contact shortly to provide a more detailed update on the OCIF and to outline next steps for those municipalities whose ICIP applications will be fast-tracked.

Thank you for your support as we continue to fund better infrastructure for the people, making smarter infrastructure investments throughout all municipalities and Indigenous communities across Ontario. I look forward to working with you to invest in and address the infrastructure needs of your community.

On March 20, 2019, the Government of Ontario <u>announced one-time funding</u> for small and rural municipalities to improve service delivery and efficiency.

405 municipal governments have received letters from MMAH Minister Steve Clark outlining their funding allocation and details of the government's expectations. The letter recommends the money be used to improve how municipalities deliver services to reduce ongoing costs of providing those services. The use of this money is another opportunity for municipal governments to demonstrate to their taxpayers and the province how they can move innovation forward.

There are resources available for municipalities to learn more about best practices related to efficiency, effectiveness and innovation. The Minister's letter indicates ministry regional offices can assist with ideas about how best to invest the funds.

AMO also has information resources available. From 2010 to 2014, AMO delivered a project funded by MMAH called the Ontario Municipal Knowledge Network (OMKN). While the project concluded in 2015, the information assembled is still available on the OMKN website at <u>www.omkn.ca</u>. While the site is archived, it contains a wealth information on best practices. It also contains customized <u>search capacity</u> linked to key municipal best practice sources in North America and Europe.

VE Study Highlights

A two-day Value Engineering Session was held on September 5-6, 2018

Study Purpose

- Identify two new site locations for the Halton North Truck Inspection Stations along Highway 401 (eastbound and westbound)
- Existing stations located near Trafalgar Road to be closed by widening of Highway 401 (approved in 2013 TESR)
- Upgrade the facilities to Commercial Vehicle Inspection Facility (CVIF) Standards



Study Area

This study area was determined based on the following:

- east of Regional Road 25 is planned for core/collector system
- a connection between Highway 6 South and Highway 6 North (Morriston Bypass) has environmental assessment approval (2016) and cannot support a CVIF
- no existing or planned core-collector highway system
- outside of an urbanized area
- sufficient space to have access in and out of the potential sites

Study Process



This study follows a specific process

known as the Class Environmental Assessment Process for Provincial Transportation Facilities.

It is an approved environmental assessment process for highway planning, design, and construction projects. The planning phase of this project evaluated alternatives to the undertaking and determined that the only viable solution to the problem was to construct new CVIFs west of Regional Road 25, as identified at PIC #1.

Class Environmental Assessment Process for Group 'B' Projects

The Group 'B' process is used for major improvements to existing provincial transportation facilities.

This includes highway improvements that identify significant widening of the highway footprint; e.g., a commercial vehicle inspection facility (CVIF).

Public Information Centre #2, November, 2018



At the end of the study, separate Transportation Environmental Study Reports (TESRs) for each site will be filed for a 30-day Public Review Period.

RECOMMENDATION

That Report ADM-2019-016 regarding Proposed Mapping Revisions to the Grand River Source Plan and Associated Assessment Report be received for information; and

And that Council hereby provides a Municipal Resolution in support of the proposed revisions to the Grand River Source Protection Plan and associated Assessment Report.

Background

The Township of Puslinch is part of two Source Protection Regions, including the Lake Erie Source Protection Region – Grand River Source Protection Plan. The Grand River Source Protection Plan came into effect on July 1, 2016. This report summarizes proposed revisions to mapping in the Grand River Source Protection Plan and outlines staff comments on the proposed revisions. Attachment 1 provides the pre-consultation notice dated February 12, 2019 including draft, updated policy applicability maps for Wellington County and two additional draft, updated maps not included in the pre-consultation notice. This topic and a related topic, the Cambridge East Environmental Assessment, was previously reported to Council in ADM-2017-013, ADM2018-017, ADM2018-033 and ADM2018-039. The Cambridge East Environmental Assessment is not the subject of this report as that study's results are not included in these proposed mapping revisions.

A Township of Puslinch resolution is required as the proposed revisions affect the Township and County. A County Council resolution will also be required. There are also separate mapping changes that affect the Town of Erin and a Town of Erin resolution will also be required. The proposed amendment is a locally initiated amendment (initiated by the Source Protection Authority and Source Protection Committee) under Section 34 of the Clean Water Act. That Section of the Clean Water Act requires Council resolutions from affected municipalities prior to public consultation. A municipality may be considered "affected" if it is located within a

geographic area related to the amendments, and / or the municipality is responsible for taking actions or otherwise implementing source protection policies related to the amendments. Public consultation on this amendment is tentatively scheduled for April 8th until May 21, 2019 depending on the receipt of Council resolutions. The Source Protection Committee may also decide to proceed with public consultation in advance of all Council resolutions being received.

The Grand River Source Protection Plan is divided into municipal chapters. The proposed revision affecting the Township of Puslinch is to revise existing maps in the Grand River Source Protection Plan (Wellington County chapter) and associated Assessment Report (Waterloo Region and City of Guelph chapters). There will be associated text changes as well in the Assessment Report (Waterloo Region and City of Guelph chapters). The mapping revisions for the Township of Puslinch include wellhead protection area and issues contributing area mapping for the City of Cambridge municipal water system and wellhead protection area mapping for the City of Guelph municipal water system. The mapping revisions are a result of changes to the City of Cambridge municipal water system and updated geological and hydrogeological modelling by the Region of Waterloo using their Tier 3 water quantity models. The Cambridge mapping revisions are part of a comprehensive update that the Region of Waterloo has undertaken for all their municipal wellhead protection areas and intake protection zones. The City of Guelph mapping revisions are a minor change to include the Glen Collector on the mapping. Further information will be available on the Lake Erie Source Protection Region website at <u>www.sourcewater.ca</u> once public consultation begins and in their April 4, 2019 agenda package once posted.

<u>Purpose</u>

For Council's reference, the proposed mapping revisions are shown in Attachment 1 while the current mapping in the approved Grand River Source Protection Plan are shown in Attachment 2. The following discussion compares the current mapping with the proposed revisions. A discussion on the impact to property owners is provided after the comparison of the mapping.

Map Revisions

The first map in both Attachments is the index map. This has changed to reflect the addition of new inset maps. The current Figure 7.22 Schedule Q Map A1 in Attachment 2 is proposed to be changed to Township of Puslinch Map B (draft) in Attachment 1. There is no change in the underlying data between these maps, however, there is a change in the map orientation due to the removal of an inset map. The removed inset map, Figure 7.22 Schedule Q Map A2 in Attachment 2, has now become Township of Puslinch Map A (draft) in Attachment 1. There are major changes between these maps as the updated modelling for the Cambridge municipal water system indicates Wellhead Protection Area B (2 year time of travel) and Wellhead Protection Area C (5 year time of travel) now extend farther into the Township. There is also a corresponding increase in vulnerability scores with scores ranging from 6 to 10. Not shown in Attachment 1 and

2 are also larger Wellhead Protection Area D (25 year time of travel). These are shown in Attachment 3.

The current Figure 7.23 Schedule R Map B in Attachment 2 becomes Township of Puslinch Map C (draft) in Attachment 1. The only change between these maps is the addition of a Wellhead Protection Area A (100 metre radius) around the Glen Collector within the City of Guelph Arkell Spring Grounds. This is shown as a small increase in the red area (vulnerability score 10) located entirely within the City property. The current Figure 7.26 Schedule U, Township of Puslinch Issues Contributing Areas in Attachment 2 becomes Draft Figure 7.27 Schedule V, Township of Puslinch Issue Contributing Areas in Attachment 1. There are no changes to the mapping around Arkell (Map A in the current mapping and Map B in the draft mapping) beyond the change in title. The major changes are related to the extension of the Chloride issues contributing areas originating from Cambridge and the removal of the nitrate and sodium issues contributing areas originating from Cambridge. It is understood that the removal of the Cambridge nitrate and sodium issues contributing areas is related to changes in the municipal well depth and construction. The draft Figure 7.28 Schedule W – County of Wellington, Intake Protection Zones in Attachment 1 is shown for reference only, there are no changes beyond the title.

There are 759 properties in the draft wellhead protection areas within the Township of Puslinch. A total of 322 properties are only contained within the Wellhead Protection Area D (25 year time of travel) and therefore, no significant threat policies apply to these properties. The only additional policy requirement for these properties will be the requirement to fill out the Township and County <u>Drinking Water Source Protection Screening Form</u> when applying for development approval through the Planning and Building Departments. This form is required in the Wellhead Protection Area D to fulfill the Township and County's legal responsibility to track creation of transport pathways within the wellhead protection areas. The tracking of transport pathway creation is also required in all wellhead protection areas. A transport pathway can be a number of activities including improperly maintained wells, geothermal systems, fractured bedrock excavation and aggregate operations.

For the remaining 437 properties, there is a range of significant threat policies that may apply to these properties. The policy requirements range from compliance based policies such as septic inspections and risk management plans to education or incentive based policies. Township risk management staff have completed desktop analysis of these 437 properties and have identified 32 properties that potentially could require septic inspections or risk management plans for road salt, chemical handling or agricultural activities. The remaining 405 properties are primarily agricultural, residential or seasonal properties and as such would primarily be subject to education or incentive policies. It is possible that some of the agricultural properties identified in the 405 properties may also be subject to chemical handling risk management plans, however, typically risk management plans for agricultural properties are limited to the vulnerability score 10 (red area) as discussed below.

The desktop analysis comprises of air photo interpretation and analysis of data such as MPAC property codes. The septic inspections are limited to 5 properties located in the vulnerability score 10 (red area) along Townline Road. Septic inspections are required every 5 years and the Township's next program is scheduled to begin in 2020. The risk management plans are primarily for either road salt application or storage or dense non-aqueous phase liquids (chemical) handling or storage. The properties identified as potentially requiring these types of risk management plans appear to be primarily industrial, commercial or institutional uses. There may also be a limited number of risk management plans on up to 3 agricultural properties depending on what activities are present on those properties. The activities could include nutrient application or storage, pesticide application or storage, fuel handling or storage, livestock grazing, waste handling and chemical handling or storage.

The majority of the 32 properties are located within the expanded chloride issues contributing area and are properties that appear to have large parking lots or paved surfaces, based on the 2015 air photos. The properties included are primarily multi-residential, industrial, commercial, institutional properties and parks, car pool lots or conservation lands with parking lots. There are some farm properties included when there appeared to be a large parking lot or paved surface present. It is important to note that these properties have been identified as potentially needing a risk management plan for road salt application or storage, however, a risk management policy for road salt application or storage is currently not included in the Wellington County Chapter of the Grand River Source Protection Plan. There are planned updates to the policies in the Wellington County Chapter later in 2019 including a reassessment of the road salt application and storage policies. This reassessment is in part due to the Cambridge mapping changes but is, in larger part, due to the identification of two issues contributing areas for chloride in Elora and Fergus. No decision has been made at this time related to inclusion of risk management plan policies for road salt application and / or storage, however, those policies are in place in other Source Protection Plans or municipal chapters within the Grand River Source Protection Plan including the Region of Waterloo municipal chapter. Any proposed policy changes would come to all affected Wellington County municipal Councils, including the Township, for review and discussion at a later date. A separate Council resolution will be under consideration at that time for any policy changes. The current Council resolution is only related to the proposed mapping revisions.

To date, no field verification of any properties within the draft wellhead protection areas have been completed. Risk Management staff will be conducting that work in the future and will directly discuss potential requirements with affected property owners.

Public Consultation

On March 27, 2019, a public meeting was held at the Grand River Conservation Authority office. Risk management staff were in attendance along with Region of Waterloo and Grand River

Conservation Authority staff. Letters were mailed out to the 32 properties discussed above and advertisements were placed in the Wellington Advertiser. Due to time constraints, it was not possible to place an advertisement in the Puslinch Pioneer. Following the Lake Erie Source Protection Committee meeting on April 4, 2019, public consultation on this amendment is tentatively scheduled for April 8th until May 21, 2019.

Recommendation

Staff recommend that Council support the proposed revisions to the mapping as outlined above.

Financial Implications

An increased number of properties with source protection requirements does result in increased Township staff workloads and cost. A complete analysis of the increased workload is still ongoing. Regional staff have indicated a willingness to meet and discuss costs related to the expanded wellhead protection areas.

Since approval, additional technical studies have been completed in the Region of Waterloo, City of Cambridge and Regional Municipality of Halton, Town of Halton Hills. These studies included a WHPA update for the Cambridge Well Supply and the delineation of a new WHPA for water quantity for the Town of Acton municipal supply system. In addition, a new WHPA-A has been delineated for the Glen Collector System, City of Guelph Waterworks, as part of a mapping exercise.

The Grand River Source Protection Authority is the lead authority in the Lake Erie Source Protection Region and as such along with the Lake Erie Region Source Protection Committee initiated an update to the Grand River Source Protection Plan and Assessment Report under s.34 of the *Clean Water Act, 2006.*

The draft updated policy applicability maps for Wellington County are included in Appendix A.

Background

In 2017, Council authorized entering into a Site Plan Agreement for the property known municipally as 29 Winer Road (the "subject property") for the purpose of building a transport terminal. The subject property is located within a site plan control area and is zoned Industrial which permits a transport terminal.

Purpose:

The development of the property has been progressing towards completion with the lighting and a couple of other items to be completed. The owner has requested that the agreement be amended to delete the current lighting plan and replace it with a new lighting plan, with reduced lighting, since there are no buildings on the lot. The request was forwarded to the Township's consultant, and upon review of the new lighting plan advised that the existing Township Standards aren't specific in terms of minimum lighting requirements, and suggested that minimum requirements as per the *IES RP-20-14 Lighting for Parking Facilities* would be appropriate. The owner has advised the Township's consultant that he is confident that the amended lighting plan will meet his requirements for use and security of the site.

Amendments to Schedule B of the Site Plan Agreement

It is recommended that Schedule B be updated and that an amending agreement be registered on title to reflect final approved drawings.

An updated Schedule "B" is attached as Schedule "A" to this report for Council's information.

To the Honourable Jeff Yuerk, Minister of Transportation,

January 27, 2019

It is my pleasure to provide you with a synopsis of the importance of the Highway 6 by-pass around the hamlet of Morriston, both economically and locally.

Some of the facts I would like to draw to your attention is the affect the "bottle neck" on the economy. In the report submitted by Dr. Clarence Woudsma from the University of Waterloo in the fall of 2013, the following were outlined as economic impacts to businesses and residents:

- Estimated annual commuter travel time saved during peak periods with the proposed bypass applied to 2011 traffic is \$13.1 Million dollars, \$23.4 (2021), \$31.3 (2031). Along with this is the reduction in consumption of fossil fuels thus reducing emissions (co2).
- The study area route provides an essential link locally and regionally, between a large portion the Lake Huron, Bruce Region, and Hamilton/Niagara region and the Eastern Seaboard of the U.S
- Local transportation companies describe the Highway 6 current route as "painful, expensive, time consuming and dangerous".
- The consensus from local business is that the lack of a by-pass impairs productivity, increases pollution (increased fuel consumption), creates inconsistency for deliveries and shipments along with employee tardiness.
- The proposed by-pass would provide an alternative Emergency Detour Route if the 401 needs to be closed for the east or west bound lanes. This new EDR would direct traffic away from the Hamlets of Aberfoyle, Morriston and Campbellville by directing the traffic south on Highway 6 to connect to highway 403.

The economic and social benefits are much broader then I can outline in this letter. I would like to point out that completing the by-pass is very progressive. The future expansion of the 401 to 10 lanes as well as the growth targets for the area, along with the proximity to Toronto warrant preparation for future needs of the Greater Golden Horseshoe area. This project will provide economic benefits for years to come. We only need to look at our neighbours to the west. The Region of Waterloo has been very progressive. The latest project for light rail is intended to serve the community far into their future needs. I believe the same rationale can be applied to the Morriston by-pass; we need it now for the future so that as a region we are ready to support the economic growth of the future.

Dear Minister Fedeli,

The Township of Puslinch (the Township) received your letter regarding the Ontario Municipal Partnership Fund and the indication that it will return to funding "Northern and rural municipalities that need it most".

Mr. Minister, I am writing you to inform you that the Township is one of the rural communities that "need it most".

To give you some background on our Township, we are located approximately 70 kilometers west of Toronto situated between the larger municipalities of Guelph, Cambridge, Hamilton and Milton to our East.

During the reorganization of municipalities in 1999, the Township survived as a stand-alone entity. We were not amalgamated due to our fiscal responsibility then, which continues to this day. Mr. Minister I can assure you that the Township provides exceptional services with the funds allocated to it through the OMPF Program.

Puslinch receives less than 20% of the total tax bill of our residents. With this small allocation we have provided the most value for every dollar we receive. The funds the Township received in 2017 from the OMPF Program accounted for 10.6% of the budgeted taxation levy. If there is a reduction in the funds allocated through the OMPF Program, Puslinch ratepayers will shoulder the burden not only from the local level of government but also its proportionate share from the upper tier Municipality (County of Wellington).

As a rural municipality in the heart of Southern Ontario, it is difficult to maintain service levels, comply with mandated new legislation (i.e. Asset management plans) and keep tax increases at or near inflation.



The Township is nearing the completion of its Asset Management Plan. All reports indicate that we are in good financial position, however there still is planning and budgeting to be done. If funding from the OMPF Program were reduced or cancelled, this would result in an approximate 11% increase on the Township's tax levy. In addition to the impacts noted above, the Township's Asset Management Plan is recommending a 3% tax increase over the next 10 years.

The prospect of a 11% tax increase before Capital and Operating budget increases have been included, is a financial hardship I do not want to place on the residents of Puslinch. Along with our record of fiscal responsibility, ability to deliver great value for every dollar of revenue we receive, this makes the Township of Puslinch a great candidate for continued funding from OMPF.

I do believe OMPF funding is integral to all municipalities that have received the funding in the past and it is my hope the Government will continue this funding as my letter shows how important it is to each and every one of the communities involved.

BY-LAW NO 021-2019

A by-law to authorize the temporary borrowing of funds to meet current expenditures of the Corporation of the Township of Puslinch during the fiscal year ending December 31, 2019.

WHEREAS in accordance with Section 407 of the Municipal Act, S.O. 2001, c. 25 as amended, the Corporation of the Township of Puslinch ("Township") considers it necessary to have authorization in place in the event that temporary borrowing is required to meet current expenditures for the year 2019 until taxes are collected; and

WHEREAS the total amount which may be borrowed from all sources at any one time to meet the current expenditures of the Municipality, except with the approval of the Ontario Municipal Board, is limited by Section 407 of the Municipal Act, 2001, S.O. 2001, c.25, as amended; and

WHEREAS the total amount previously borrowed by the Township pursuant to Section 407 that has not been repaid is NIL.

NOW THEREFORE the Council for the Corporation of the Township of Puslinch hereby enacts as follows:

- That the Mayor and Treasurer be and the same are hereby authorized on behalf of the Township to borrow from time to time by way of a promissory note from THE TORONTO DOMINION BANK ("TD") a sum or sums not exceeding in the aggregate of \$1,500,000.00 to meet, until taxes are collected, the current expenditures of the Township for the year as permitted by Section 407 of the Municipal Act and to give to TD promissory notes, sealed with the Township's corporate seal and signed by the Mayor and Treasurer for the sums borrowed plus interest at a rate to be agreed upon from time to time with TD.
- 2. That the total amount borrowed at any one time plus any outstanding amounts of principal borrowed and accrued interest shall not exceed,
 - a) from January 1 to September 30 in the year, 50 percent of the total estimated revenues of the municipality as set out in the budget adopted for the year; and
 - b) from October 1 to December 31 in the year, 25 per cent of the total estimated revenues of the municipality as set out in the budget adopted for the year.
- 3. For purposes of this by-law, the estimated revenues referred to in section 2 do not include revenues derivable or derived from: a) any borrowing, including through any issue of debentures; b) a surplus, including arrears of taxes, fees or charges; or c) a transfer from the capital fund, reserve funds or reserves.
- 4. All sums borrowed pursuant to this by-law, as well as all other sums borrowed pursuant to the Act in this year for any purpose will, with interest thereon, be a charge upon the whole of the revenues of the Township for the current year and when this revenue is received.

5. The Treasurer is authorized and directed to apply in payment for all sums borrowed plus interest, all of the monies collected or received on account in respect of taxes levied for the current year or from any other source which may lawfully be applied for this purpose.

AND WHEREAS the *Planning Act,* R.S.O. 1990, c.P.13, authorizes the entering into of agreements to ensure the provision of any and all facilities, works or matters and maintenance;

BY-LAW NUMBER 023-2019
